

**WTA/DAVE WELDY SCHOLARSHIP PROGRAM**  
**VOCATIONAL APPLICATION**

The Vocational Scholarship was initiated primarily for the applicant looking to further their education in trades associated with the trucking industry. Annual grants of \$250 to \$2,000 for vocational scholarships will be awarded by the Washington Trucking Associations to eligible students with preference given to candidates who are related to an employee of a current WTA member. The scholarship fund is sponsored by the Suppliers Conference of the Washington Trucking Associations. All proceeds from the Roger Mauch Memorial Golf Tournament and the WTA Eastside Golf Classic are donated to this scholarship fund.

***Vocational Scholarship – Diesel Mechanics & Truck Drivers***

***Mechanics:*** *Diesel mechanic training is a two-year program at local vocational schools with the year divided into four quarters and the month of September being vacation time. Eligible students must have completed high school or the GED equivalent, or be enrolled in a vocational school.*

*The schools will provide the WTA Scholarship Committee with a list of candidates that includes vocational achievements, class attendance, and professional aptitude and citizenship ratings. The Committee will award Vocational scholarships with preference going to someone associated with the WTA.*

***Truck Drivers:*** *There are several truck driving schools in the state and each class is approximately six months long. Tuition is approximately \$2,000. The schools will provide the Scholarship Committee with a list of eligible candidates. The Committee will award Vocational scholarships with preference going to someone associated with the WTA.*

***All applications must be received at the WTA office no later than June 30, 2012.***

The Scholarship Committee will review the applications in July, and recipients will be announced on or about August 10, 2012. Recipients of Vocational Scholarship Awards may use funds to attend accredited colleges or universities, community colleges, or vocational institutions.
